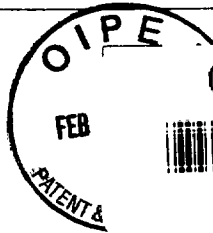



ASSIGNMENT

WHEREAS, I, ALISTER PETER REID a British citizen residing at 30 Cheyne Court, Floor Street, London SW3 5TR, England (hereinafter ASSIGNOR), have invented a certain new and useful invention entitled PET DOOR, for which an application for Letters Patent of the United States which was filed September 18, 1998 and having Serial No. 09/156,455;

AND WHEREAS, REILOR LIMITED, (hereinafter ASSIGNEE), a British Company of Blackpool Road, Preston, Lancashire, PR2 2DN, England, is desirous of acquiring an interest therein; and all patents obtained therefor;

representatives.

AND, I HEREBY agree to transfer a like interest, upon the request of said ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, in and to any improvements, and applications for patent based thereon, growing out of or related to the said invention; and to execute any papers by the said ASSIGNEE, its successors, assigns and legal representatives, deemed essential to ASSIGNEE's full protection and title in and to the invention hereby transferred.

Agreeing furthermore, upon request of said ASSIGNEE, and without further remuneration, to execute any and all papers desired by said ASSIGNEE for the filing and granting of foreign applications and the perfecting of title thereto in said ASSIGNEE.
