

**CERTIFICATE OF OWNERSHIP AND MERGER MERGING
CHATTANOOGA CORPORATION AND CHATTECX CORPORATION
INTO CHATTANOOGA GROUP, INC.**

**(Pursuant to Section 253 of the General
Corporation Law of Delaware)**

Chattanooga Group, Inc., a Delaware corporation (the "Corporation"), does hereby certify:

FIRST: That the Corporation is incorporated pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Corporation owns all of the outstanding shares of each class of the capital stock of Chattanooga Corporation, a Delaware corporation, and Chattecx Corporation, a Delaware corporation.

THIRD: That the Corporation by the following resolutions of its board of directors, duly adopted on the 19th day of May, 1992, determined to merge into itself Chattanooga Corporation and Chattecx Corporation on the conditions set forth in such resolutions:

RESOLVED: That Chattanooga Group, Inc. merge into itself each of its two wholly-owned subsidiary corporations, Chattanooga Corporation and Chattecx Corporation, and assume all of each of said subsidiary's liabilities and obligations;

FURTHER RESOLVED: That the President and the Secretary of this Corporation be and they hereby are directed to make, execute and acknowledge a certificate of ownership and merger setting forth (i) a copy of the resolution to merge each of said Chattanooga Corporation and Chattecx Corporation into this Corporation and to assume each of said subsidiary's liabilities and obligations, and (ii) the date of adoption thereof and to

file the same in the Office of the Secretary of State of Delaware and a certified copy thereof in the Office of the Recorder of New Castle, Delaware.

IN WITNESS WHEREOF, said Corporation has caused its corporate seal to be affixed, and this certificate to be signed by John H. P. Maley, as president, and Peggy Greever, as secretary, this 24th day of June, 1992.
