WHEREAS, I am the sole inventor of certain new and useful improvements in **SYSTEMS AND METHODS FOR COAXIALLY COUPLING AN ANTENNA TO A RADIOTELEPHONE THROUGH A WINDOW AND AMPLIFYING SIGNALS ADJACENT AND INSIDE THE WINDOW** for which an application for United States Letters Patent has been executed by me concurrently herewith, and
