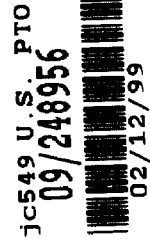

WHEREAS, we are the joint inventors of certain new and useful improvements in **BLENDING SYSTEM AND METHOD USING AN AUXILIARY MEASURING DEVICE** for which we are about to make application for Letters Patent of the United States, and for which we have executed a declaration on the 9th day of February, 1999.

We hereby request the Assistant Commissioner for Patents to issue the Letters Patent in accordance with this instrument.

For the consideration aforesaid, we have sold, assigned, transferred and set over, and by


