ASSIGNMENT

WHEREAS, RICHARD M. BERGER, whose address is 3612 Quail Meadows Place, Midlothian, Virginia 23112 (hereinafter referred to as "ASSIGNOR") has invented certain new and useful improvements in a METHOD AND APPARATUS FOR SPINNING A WEB OF MIXED FIBERS, AND PRODUCTS PRODUCED THEREFROM for which he is about to make application for United States Letters Patent;

WHEREAS, FILTRONA INTERNATIONAL LIMITED, a company of Great Britain, located at 110 Park Street, London W1Y 3RB, UNITED KINGDOM, (hereinafter "ASSIGNEE"), is desirous of acquiring the entire right, title and interest in and to the said application, and any Letters Patent that may issue thereon anywhere in the world;


NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR has and by these presents does hereby sell, assign and transfer unto ASSIGNEE, its successors and assigns, ASSIGNOR's entire right, title and interest in and to said invention, as described in the aforesaid application, in any form or embodiment thereof, and in and to the aforesaid application, and in and to any application filed in any foreign country based thereon, including the right to file said foreign applications under the provisions of the International Convention; also ASSIGNOR's entire right, title and interest in and to any and all design patents, reissues or extensions thereof, to be obtained in this or any foreign country upon said invention, and any divisional, continuation, continuation-in-part, or substitute applications or supplementary disclosures which may be filed upon said invention in any country; and ASSIGNOR hereby authorizes and requests the issuing authority to issue any and all patents on said application to ASSIGNEE.

ASSIGNOR further agrees, without any payment by ASSIGNEE other than expenses incurred by ASSIGNOR, to communicate to ASSIGNEE, its representatives or agents any facts

relating to said invention, including evidence for interference purposes or for other proceedings, whenever requested; and execute and deliver on request all lawful papers required to make these provisions binding upon ASSIGNOR's heirs, legal representatives, administrators and assigns; and ASSIGNOR hereby warrants that, at the time of execution and delivery of this Assignment, ASSIGNOR is the lawful owner of the entire right, title and interest in and to said invention and said application, that the same are unencumbered, and that it has good and full right and lawful authority to sell and convey the same in the manner herein set forth.


