WHEREAS WE, **Jared LeVan Zerbe**, a resident of Palo Alto, California; **Michael Tak-kei Ching**, a resident of Sunnyvale, California; **Abhijit M. Stonecypher**, a resident of San Jose, California, have invented certain new and useful improvements in a **METHOD AND APPARATUS FOR FAIL-SAFE RESYNCHRONIZATION WITH MINIMUM LATENCY**, having **Serial No. 09/169,372**, and **filing date of October 9, 1998**, and which invention is fully described in the specification pertaining to said application; and

executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of the assigns and legal representatives of both parties.
