WHEREAS, the undersigned,

hereinafter termed "Inventor", has invented a design for a

WIRELESS HANDHELD COMPUTER

and has filed an application for a United States patent disclosing and identifying the above design on October 30, 1998, as Application No. 29/095,841 (hereinafter termed "application"); and

WHEREAS, 3Com Corporation, a corporation of the State of Delaware, having a place of business at 5400 Bayfront Plaza, Santa Clara, California 94052, (hereinafter termed "Assignee"), is desirous of acquiring the entire right, title and interest in and to said application and the design disclosed therein, and in and to all embodiments of the design, heretofore conceived, made or discovered by said Inventor (all collectively hereinafter termed "said design"), and in and to any and all patents, inventor's certificates and other forms of protection (hereinafter termed "patents") thereon granted in the United States and foreign countries.

NOW, THEREFORE, in consideration of good and valuable consideration acknowledged by said Inventor to have been received in full from said Assignee:

1. Said Inventor does hereby sell, assign, transfer and convey unto said Assignee the entire right, title and interest (a) in and to said application and said design; (b) in and to all rights to apply for foreign patents on said design pursuant to the International Convention for the Protection of Industrial Property or otherwise; (c) in and to any and all applications filed and any and all patents granted on said design in the United States or any foreign country, including each and every application filed and each and every patent granted on any application which is a divisional, substitution, continuation, or continuation-in-part of any of said applications; and (d) in and to each and every reissue or extensions of any of said patents.


2. Said Inventor hereby covenants and agrees to cooperate with said Assignee to enable said Assignee to enjoy to the fullest extent the right, title and interest herein conveyed in the United States and foreign countries. Such cooperation by said Inventor shall include prompt production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, specifications, declarations or other papers, and other assistance all to the extent deemed necessary or desirable by said Assignee (a) for perfecting in said Assignee the right, title and interest herein conveyed; (b) for prosecuting any of said applications; (c) for

filing and prosecuting substitute, divisional, continuing or additional applications covering said design; (d) for filing and prosecuting applications for reissuance of any said patents; (e) for interference or other priority proceedings involving said design; and (f) for legal proceedings involving said design and any applications therefor and any patents granted thereon, including without limitation reissues and reexaminations, opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions and court actions; provided, however, that the expense incurred by said Inventor in providing such cooperation shall be paid for by said Assignee.

3. The terms and covenants of this assignment shall inure to the benefit of said Assignee, its successors, assigns and other legal representatives, and shall be binding upon said Inventor, his/her respective heirs, legal representatives and assigns.

4. Said Inventor hereby warrants and represents that he/she has not entered and will not enter into any assignment, contract, or understanding in conflict herewith.
