- (l) any and all extension of, and additions to, said Letters Patent of countries foreign to the United States of America.

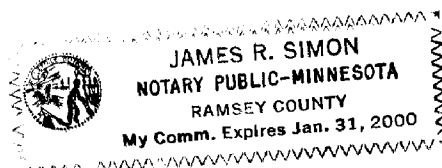
