ASSIGNMENT

WHEREAS, JOHN E. BERG, a resident of Sunnyvale, California, BERNICE L. KICKEL, a resident of Boise, Idaho, and JOHN A. SMYTHE III, a resident of Boise, Idaho, hereinafter referred to as "Assignors," have invented certain new and useful improvements as described and set forth in an application for Letters Patent of the United States entitled "METHOD OF FABRICATING A HIGH QUALITY THIN OXIDE," filed with the U.S. Patent Office on December 18, 1998, under Serial No. 09/215,797;
