including the full right to claim for any such application the benefits of the International Convention as fully and entirely as I could have done if the application had been filed in my name, and the entire interest in any Letters Patent which may be granted on any such application in such foreign countries, and I do authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States whose duty is to issue patents on applications as aforesaid, to issue said Letters Patent to LuK Getriebe-Systeme GmbH its successors, assigns, nominees or other legal representatives, as assignee and owner of the said entire interest, and I do covenant that I have full right to convey the said entire interest herein assigned and that I have not executed and will not execute any agreement in conflict herewith, and agree that I will communicate to LuK Getriebe-Systeme GmbH its successors, assigns, nominees, or other legal representatives, all facts known to me respecting said improvements, whenever requested, and testify in any legal proceedings, sign all lawful papers, execute and deliver all divisional, continuing and reissue applications, make all rightful oaths and do all lawful acts requisite for the application of such divisional, continuing or reissue applications, or the procuring thereof, and that if and when LuK Getriebe-Systeme GmbH, its successors, assigns, nominees or other legal representatives desire to file a disclaimer relating thereto, I will, upon request, sign and deliver all lawful papers requisite for the filing of such disclaimer, and I further covenant and agree that I will, at any time upon request, do everything possible to aid LuK Getriebe-Systeme GmbH, its successors, assigns, nominees or other legal representatives, either in my or its own name, to apply for, obtain and enforce proper patent protection for said

improvements in all countries according to the International Convention of 1883 and all the laws and treaties in force, all without further consideration but at the expense of LuK Getriebe-Systeme GmbH its successors, assigns, nominees and other legal representatives.
