

I hereby authorize and request the Patent and Trademark Office officials in the United States of America to issue any and all of said patents, when granted to said Lindén International AB, as the assignee of my entire right, title and interest in and to the same for the sole use and enjoyment of said Lindén International AB, its successors and assigns.

Further, I agree to execute all papers and to give such lawful testimony and to perform such other lawful acts as said Lindén International AB, its successors and assigns

may require to enable it or them to procure a Design Patent on said invention or reissues or extensions thereof in the United States of America, and/or to hold, enforce or convey said Design Patent, reissues or extensions.
