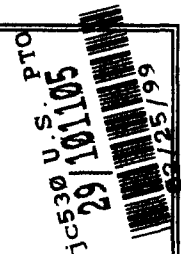

ASSIGNMENT OF DESIGN

WHEREAS, WE, **John C. Diebel, John E. Smith, Clair A. Samhammer, and David M. Hines**, residing at 9 Lochmoor Lane, Newport Beach, California 92660; 21862 Camargo, Mission Viejo, California 92691; 1091 N. Granada Drive, Orange, California 92669; and 13872 Gershon Place, Santa Ana, California 92705, respectively, have invented an ornamental design disclosed in an application for United States Letters Patent entitled **SPOTTING SCOPE**, and executed by us on even date herewith;

AND WHEREAS **MEADE INSTRUMENTS CORPORATION**, a Delaware corporation, having a place of business at 6001 Oak Canyon, Irvine, California 92620-4205 (hereafter, together with any successors, legal representatives or assigns thereof, called "ASSIGNEE") wants to acquire the entire right, title and interest in and to said improvements and application.

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith;

AND WE HEREBY further covenant and agree that we will communicate to ASSIGNEE any facts known to us respecting said design, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said design in all countries.


