Whereas I, the undersigned, Miriam Rits, hereby have made certain inventions or discoveries (or both) set forth in an application for Letters Patent of the United States of America entitled, **VENTED FLASK CAP FOR ABSORBING RADIOACTIVE GASES**, identified as Attorney Docket No. 22711-5; and


5. Bind my heirs, legal representatives and assigns, as well as myself, to do, upon Assignee's request and at Assignee's expense, but without additional consideration to me or
