

ASSIGNMENT

WHEREAS, I, GARY M. HAZARD, residing at Post Office Box 401, Spring Hill Road, Morrisville, Vermont 05661, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **WAVE FLAME CONTROL**, filed **November 25, 1998**, Application No. **09/200,222**.

AND WHEREAS SUPERIOR FIREPLACE COMPANY, a **State of Delaware** corporation, having a place of business at 4325 Artesia Avenue, Fullerton, California 92833-2522 (hereafter, together with any successors, legal representatives or assigns thereof, called "ASSIGNEE") wants to acquire the entire right, title and interest in and to said improvements and application.

AND I HEREBY further covenant and agree that I will communicate to ASSIGNEE any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said improvements in all countries.
