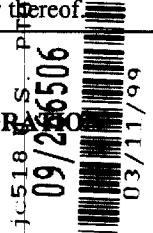

WHEREAS, We, **Alan M. Green, Jim H. Kuo, and Jeoff M. Krontz** are joint inventors of "**METHOD AND APPARATUS FOR DISABLING A PROCESSOR IN A MULTIPROCESSOR COMPUTER,**" application for United States Letters Patent which is executed of even date herewith; and
