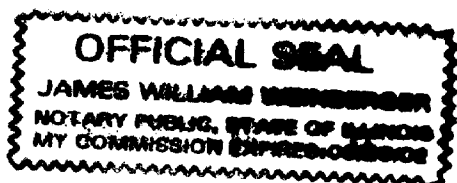

Pruett, residing in the City of Cypress, the State of California, respectively, have invented certain new and useful improvements ULTRA LOW FRICTION CARBON/CARBON COMPOSITES FOR EXTREME TEMPERATURE APPLICATIONS and SGL Carbon Composites, Inc., a corporation organized and doing business under the laws of the State of Delaware, having a place of business at SGL Carbon Composites, Inc., 1600 W. 135th Street, Gardena, California 90249-2506, desires to acquire the rights to this invention.
