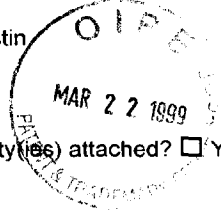


**ASSIGNMENT**






