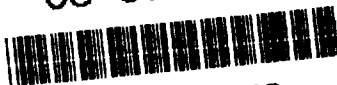

and every patent claim resulting from a reexamination certificate for any and all of said patents.


