AND IWE, Assignor, have agreed to and do hereby sell, assign, and transfer unto Non-U.S. Assignee my/our entire right, title, and interest in all countries other than the United States of America, along with the right to claim priority based on the Application, in and to the Invention, all non-U.S. patent applications based on or claiming priority to the Application, and any and all patents (including extensions, reissues, and reexaminations thereof) of such countries that have been or may be granted on the Invention or any part thereof, or on any non-U.S. patent application based on or claiming priority to the Application, or on any divisional, continuation, renewal, reissue, or other patent application based in whole or in part on the Application, any patent application based on or claiming priority to the Application, or the Invention ("the Non-U.S. Patent Rights"); the Non-U.S. Patent Rights **TO BE HELD AND ENJOYED** by Non-U.S. Assignee, its successors, and assigns to the full ends of the respective terms or periods for which the Non-U.S. Patent Rights are pending, in force, or have been or may be granted or extended, as fully and entirely as the same would have been held and enjoyed by me/us had no assignment of said right, title, and interest have been made.






