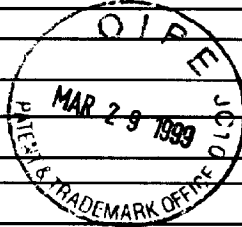

WHEREAS, I, ARMIN WIRZ, a citizen of Switzerland, residing at IM GRUND, CH-8475 OSSINGEN, SWITZERLAND (hereinafter referenced as ASSIGNOR), have invented a certain new and useful invention entitled SPIN DRAW TEXTURISING OR DRAW TEXTURISING MACHINE, for which an application for Letters Patent of the United States has been filed in the United States Patent and Trademark Office;

AND WHEREAS, MASCHINENFABRIK RIETER AG, having its principal office and place of business at KLOSTERSTRASSE 20, CH-8406 WINTERTHUR, SWITZERLAND, (hereinafter ASSIGNEE) is desirous of acquiring an interest therein;

And I hereby agree, at the expense of ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue, and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in ASSIGNEE and to aid ASSIGNEE to obtain and enforce proper protection for said invention in all countries.

And I hereby agree to transfer a like interest, upon the request of said ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, in and to any improvements, and applications for patent based thereon, growing out of or related to the said invention; and to execute any papers by the said ASSIGNEE, its successors, assigns and legal representatives, deemed essential to ASSIGNEE's full protection and title in and to the invention hereby transferred.
