Robert J. Yurkovic of Ringwood in the County of Passaic and State of New Jersey,

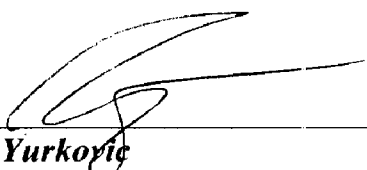

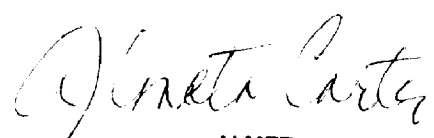
