## ASSIGNMENT

continuation application, or to secure a reissue of such Letters Patent, or to file a disclaimer relating thereto, it will, upon request, sign all papers, make all rightful oaths, and do all lawful acts requisite for the filing of such disclaimer without further compensation, but at the expense of said Assignee, its successors or other legal representatives.

Assignor further covenants and agrees that it will, at any time, upon request, promptly communicate to said Assignee, its successors, assigns or other legal representatives, such facts relating to said invention and Letters Patent or the file history thereof as may be known to Assignor, and to willingly testify as to the same in any interference or other litigation when requested to do so.
