

**Background:**

The Assignor is the owner of the Patent Rights and the Associated Rights, which it has agreed to assign to the Assignee on the terms set out below.

**It is agreed** as follows:

**1. Definitions and interpretation**

In this Assignment, unless the context otherwise requires, the following words have the following meanings:

**2. Assignment**

In consideration of the sum of £1 (one) now paid by the Assignee to the Assignor, receipt of which is hereby acknowledged the Assignor with full title guarantee assigns to the Assignee:

- (a) the Patent Rights and the Associated Rights;
- (b) the right to apply for patent or other protection in respect of the technology which is the subject matter of the Patent Rights, and in respect of the Associated Rights in any part of the world; and

- (c) all rights of the Assignor to sue for infringement of the Patent Rights or the Associated Rights which have accrued prior to the date of this Assignment.

**3. Further assurance**

The Assignor shall at the expense of the Assignee procure that all such things are done and any further documents are executed that may reasonably be required to vest in the Assignee the full benefit of the items assigned under clause 2 and to register the Assignee in the United States as proprietor of the Patent Rights and the Associated Rights.

**4. Governing law and jurisdiction**

- 4.1 This Assignment shall be governed by and construed in accordance with English law.
- 4.2 Each of the parties irrevocably submits for all purposes in connection with this Assignment to the non-exclusive jurisdiction of the courts of England.
