## ASSIGNMENT

WHEREAS, we, Albert Zofchak, Madeline Kenney, John Obeji and Michael Mosquera, all citizens of the United States of America, residing at 6 Gulfstream Boulevard, Matawan, NJ 07747; 30 Smull Avenue, Caldwell, NJ 07006; 203 Charles Street, Clifton, NJ 07013; and 439 Penn Avenue North, Forked River, NJ 07901, respectively, have invented new and useful improvements in **“URETHANE SURFACTANTS AND THEIR USE IN PERSONAL CARE FORMULATIONS”** for which we make application for Letters Patent of the United States on even date herewith.

And we hereby authorize said ALZO to file patent applications in any or all other countries on said invention in my name or in the name of said ALZO or otherwise as said ALZO may deem advisable.

And we hereby authorize the empowered officials of all governments to issue or transfer any said Letters Patent granted, to said ALZO, as assignee of the entire right, title and interest therein or otherwise as said ALZO may direct, in accordance with this instrument or assignment.

In further consideration of said good and valuable considerations, we, Albert Zofchak, Madeline Kenney, John Obeji and Michael Mosquera, further represent and warrant to said ALZO, its successors and assigns, that there are no rights and interests outstanding inconsistent with the rights and interests granted herein and that we have not executed any instrument or granted or transferred any rights or interests inconsistent with the rights and interests granted herein and that we will not execute any instrument or grant or transfer any rights or interests inconsistent herewith, and we bind executors, administrators and legal representatives, as the case may be, to execute and deliver to said ALZO, its successors and assigns, and we hereby irrevocably appoint said ALZO as our true and lawful attorney-in-fact on our and its behalf and in our and/or its name, place and stead to execute, any further documents or instruments and do any and all further acts that may be deemed necessary or desirable by said ALZO, its successors and assigns, to vest in said ALZO, its successors and assigns, the title whose conveyance is made hereby, and to enable such title to be recorded in the United States and all other countries, and to enable said ALZO to sustain or reissue any said Letters Patent granted, and to maintain, perfect, support and protect the right, title and interest of said ALZO, its successors and assigns, in and to the said invention, and any Letters Patent granted, particularly in cases of interference and litigation.

And we further covenant and agree, in consideration of the premises, that we, our executors and administrators, will at any time upon request of said ALZO, its successors or assigns, and at its expense, communicate to said ALZO, its successors and assigns, any facts relating to the invention and improvements and the history thereof, known to us or our heirs, executors, administrators or legal representatives, and that we will testify as to the same in any interference, or other litigation when requested to do so by said ALZO, its successors and assigns.




