WHEREAS, Brian Barnes and Kirk E. Maki, citizens of the United States, residing at Pasadena, Maryland, and Eldersburg, Maryland, respectively, have invented certain new and useful improvements in a design for a WIDEMOUTH CONTAINER for which they have made application for LETTERS PATENT OF THE UNITED STATES, which application has been duly executed by them, respectively, on the 26th day of March, 1999; and



We hereby agree to sign all papers and perform all acts, without charge, but at the cost and expense of said GRAFCO Industries, L.P. as that partnership may deem necessary to make this assignment fully effective, including the execution of continuing domestic and foreign applications, furnishing information and giving testimony that may be required for maintaining said GRAFCO Industries, L.P.'s right to said invention and LETTERS PATENT, particularly in cases involving interference and litigation.
