ASSIGNMENT

I further agree upon request, without additional compensation but at no expense to myself, to execute or assent to foreign applications, and to execute all other legal documents as may be necessary or desirable to vest the enjoyment of the said entire right, title and interest hereby transferred in Parr Manufacturing Inc., its legal representatives, successors and assigns, or as the said company may direct.
