Articles of Merger

of

(a Delaware corporation, hereinafter
the "non-surviving corporation")

into

MORTON INTERNATIONAL, INC. *1989040123*
(an Indiana corporation, hereinafter
the "surviving corporation")

The undersigned corporation organized and existing
under and by virtue of the Indiana Business Corporation Law,

DOES HEREBY CERTIFY:

FIRST: That the name of the corporation surviving
the merger is MORTON INTERNATIONAL, INC., which name shall be
changed as a result of the merger to AUTOLIV ASP, INC., as
provided in the plan of merger attached as Exhibit A hereto
(the "Plan of Merger").

SECOND: That the surviving corporation is a
domestic corporation existing pursuant to the provisions of
the Indiana Business Corporation Law, incorporated on April
4, 1989.

THIRD: That the non-surviving corporation is a
foreign corporation organized under the laws of the State of
Delaware and is not qualified to do business in the State of
Indiana.

FOURTH: That the Plan of Merger, containing such
information as required by Section 23-1-40-1(b) of the
Indiana Business Corporation Law, is set forth in Exhibit A,
attached hereto and made a part hereof.

FIFTH: That, as provided in the Plan of Merger,
the Restated Articles of Incorporation attached as Exhibit B
to the Plan of Merger shall be the Restated Articles of
Incorporation of the Corporation effective as of the
effective time of the merger.

SIXTH: That the holders of the common stock of
Morton International, Inc., being the only voting group
entitled to vote, approved the plan of merger at a special
meeting of shareholders (the "Special Meeting") on April 24,
1997. On the record date for the Special Meeting,


140,644,645 shares of common stock of Morton International, Inc. were outstanding, each such share entitled to one vote on the plan of merger. 99,324,503 shares of common stock of the surviving corporation were represented at the Special Meeting, of which 97,965,432 shares were voted in favor of approving the plan of merger, 446,237 shares were voted against approving the plan of merger, and 912,834 shares abstained.

SEVENTH: That Autoliv, Inc., a Delaware corporation, and the holder of 1000 shares of common stock of ASP Merger Sub Inc., constituting all of the outstanding shares of such corporation and all of the shares entitled to vote on the plan of merger, approved and adopted the plan of merger in accordance with the provisions of Section 252 of the General Corporation Law of the State of Delaware.

EIGHTH: That the effective date and time of the merger shall be 8:30 a.m., eastern daylight time, on May 1, 1997.

In Witness Whereof, the Vice President and Secretary of the surviving corporation executes these Articles of Merger and verifies, subject to penalty of perjury, that the statements contained herein are true, this 29th day of April, 1997.

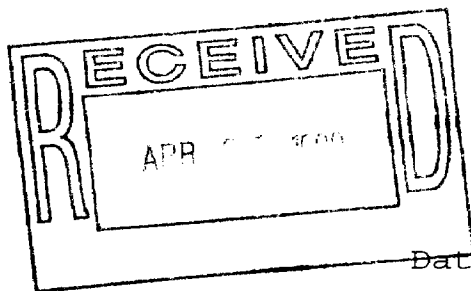
