ASSIGNMENT OF INVENTION

WHEREAS, We, Andreas Egglar residing at Rutzenbergstrasse 37, A-6922 Wolfurt, Austria, and Gottfried Rohner residing at Forststrasse 6, CH-9450 Altstätten, Switzerland have invented certain new and useful improvements in MAINS-OPERATED DEVICE FOR CURING BY LIGHT A POLYMERIZABLE DENTAL MATERIAL for which an application for Letters Patent of the United States of America was executed on the date which appears next to our signatures, and

WHEREAS, Ivoclar AG, a corporation of the state of Liechtenstein, having a place of business at Bendererstr. 2, FL-9494 Schaan, Liechtenstein, is desirous of acquiring the entire right title and interest in and to the invention, the application, and any Letters Patent(s) which may be granted therefor in the United States of America;

WE, Andreas Egglar and Gottfried Rohner further agree that we will, without charge to Ivoclar AG, but at Ivoclar AG's expense, cooperate with Ivoclar AG in the prosecution of said application and/or applications, execute, verify, acknowledge and deliver all such further papers, including applications for Letters Patent and for the reissue thereof, and instruments of assignment and transfer thereof, and will perform such other acts as Ivoclar AG lawfully may request, to obtain or maintain Letters Patent for said invention and improvement, and to vest title thereto in said Ivoclar AG, or Ivoclar AG's successors and assigns.


