AND I do hereby covenant and warrant that I have full right to convey the entire right, title and interest herein assigned





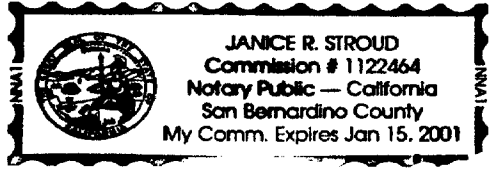
