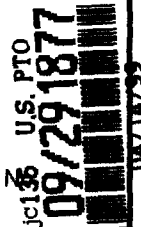


AND the Commissioner of Patents and Trademarks is requested to issue the said Letters Patent, when granted, in accordance with this assignment.


