

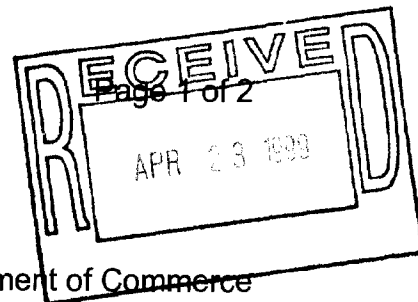

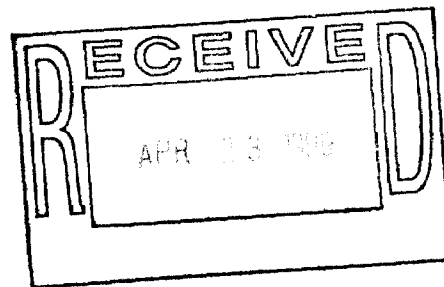

have invented a new and useful process, machine, manufacture, composition of matter, or an improvement thereof, entitled:

**A DEVICE FOR MOMENTARILY MOUNTING A SLIDING DOOR TO A
VEHICLE BODY**

for which we have executed an application for Letters Patent of the United States on September 21, 1998.
