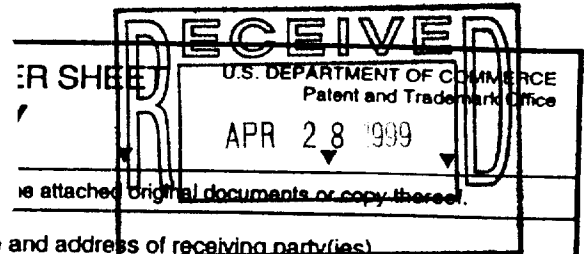



attorney, assignments, and other documents which, in the opinion of counsel for said Nordico, Inc., its successors and assigns, may be required or necessary more effectively to secure to and vest in said Nordico, Inc., its successors and assigns, the entire right, title and interest in and to said invention and improvements, applications, Letters Patent, rights, titles, benefits, privileges and advantages hereby sold, assigned, transferred and conveyed, and that we will sign any application for reissue which may be desired by the owner of the patent or patents which may be issued for said invention or improvements.
