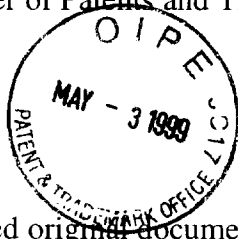



AND, SYSTEMS hereby authorizes and requests the Patent and Trademark officials in the United States and in any and all foreign countries to issue any and all letters patent on said improvements, or resulting from said patent application or said foreign patent applications, or any continuation or division thereof, or any reissue or extension of said patent, said foreign patents, or said any further patents, to LIGHTING as assignee of the entire interest, and hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.


