WHEREAS, We David A. Morgenstern of Creve Coeur, Missouri, David E. McKenzie of House Springs, Missouri, Cynthia L. Ludwig of St. Louis, Missouri; Kam-To Wan of Manchester, Missouri; Robert G. Orth of Cedar Hill, Missouri; John M. Dzenitis of St. Louis, Missouri; and David S. country which have been or may be granted on any of the aforesaid applications or on said invention or any part thereof;


