ASSIGNMENT

WHEREAS, BERNICE L. KICKEL, a resident of Boise, Idaho, and JOHN A. SMYTHE III, a resident of Boise, Idaho, hereinafter referred to as "Assignors," have invented certain new and useful improvements as described and set forth in an application for Letters Patent of the United States entitled "IN-SITU ETCH AND PRE-CLEAN FOR HIGH QUALITY THIN OXIDES," filed with the U.S. Patent Office on March 12, 1999, under Serial No. 09/267,327;

3. Assignors further agree that at the request and expense of Assignee, but without charge to said Assignee, they will promptly execute all papers necessary or desirable to perfect ownership of said invention, improvements, applications or said Letters Patent, in said Assignee, and will execute all oaths and other papers, within the truth, that are necessary or desirable for prosecuting said application, for use in interference proceedings involving said invention or


