DESIGN PATENT ASSIGNMENT


WHEREAS, Terry **GANDER**, residing at 12 Orion, Roman Hill, Bracknell, Berks, RG12 7YX, United Kingdom, and Martin **GAZE**, residing at Chapel Cottage, The Anthony's, Horsell Common, Woking, Surrey, GU21 5NL, United Kingdom, ("ASSIGNORS"), represent that they are the inventors of a certain new, original and ornamental design in an invention for a *SCALE* for which they have filed an application for Design Letters Patent of the United States on March 16 1999 and was assigned Serial No: 29/102,055

The ASSIGNORS hereby authorize and request the Commissioner of Patents and Trademarks to issue said Design Letters Patent which may be granted for said invention to the ASSIGNEE as the assignee of the entire right, title and interest therein.
