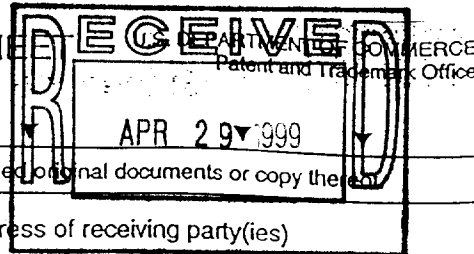

## ASSIGNMENT

WHEREAS, U.S. Patent Nos. 4,758,177, and 5,013,254, and the inventions thereof were assigned to Williams Instruments, Inc., a Texas corporation, and said patents were issued in the name of Williams Instruments, Inc.;

WHEREAS, a purported Assignment of U.S. Patent No. 5,013,254 was made to DellaWill L.P. by way of a document dated June 13, 1997, and recorded in the U.S. Patent and Trademark Office on June 24, 1997, on Reel/Frame 8574/0700. Said entity, DellaWill L.P., however never came into existence;

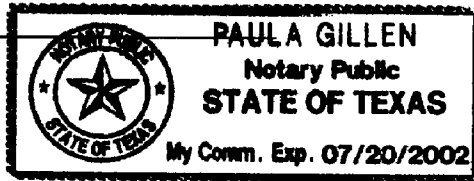

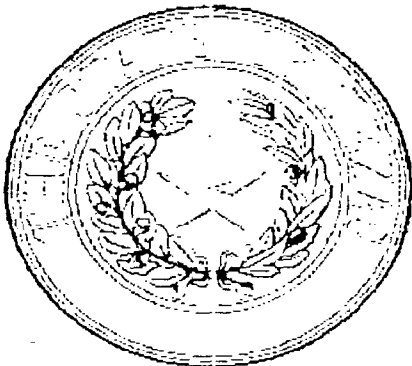
