

WHEREAS, we, Victor H. Hasson and Mark A. Kovacs have invented a certain improvement in SPECKLE MITIGATION FOR COHERENT DETECTION EMPLOYING A WIDE BAND SIGNAL described in an application for Letters Patent of the United States, Serial No. 09/277,003, filed March 26, 1999.
