ASSIGNMENT

WHEREAS, I, MARSHALL S. KRIESEL, of the City of St. Paul, Minnesota, have invented a new and useful patent for Method and Apparatus for Making Fluid Delivery Device (Docket No. 96053) for which I have on the 11th day of December _____, 1997 executed application papers for United States Letters Patent thereon; and

WHEREAS, SCIENCE INCORPORATED, a Delaware corporation, (hereinafter referred to as "Assignee"), having its principal place of business at 7760 France Ave., South, Suite 1060, Bloomington, Minnesota is desirous of acquiring the entire and exclusive right, title and interest in and to the said invention and in and to any Letters Patent which may be granted and issued therefor in the United States and throughout the world;

I also assign to Assignee, all right, title and interest to the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world including all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries and I further agree to execute any and all powers of attorney, application, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee.

I will communicate to Assignee any facts known to me respecting any improvements; and, at the expense of Assignee, I will testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in Assignee and to aid Assignee to obtain and enforce proper protection of said invention in all countries.

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue the said United States Letters Patent to Assignee, its successors and assigns.
