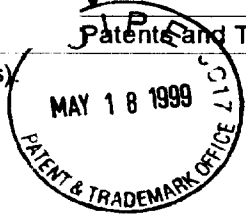



PATENT ASSIGNMENT

WHEREAS I, Mitchell F. Ghany, whose full post office address is 62 Duggan Drive, Suite 1, Brampton, Ontario, L6Y 4J2, Canada, am a joint inventor of certain inventions set forth in United States Letters Patent No. 5,685,511 dated 11 November, 1997, entitled BANNER MOUNT;
