

ASSIGNMENT

COMES NOW, DON SHOCKMAN, of Hermiston, Umatilla County, Oregon, and sells, sets over and assigns unto S & B TECHNOLOGY, INC., an Oregon corporation, all of my right, title and interest, which is an agreed upon seventy (70) percent ownership in the invention known as *MAGNETIC WHEEL GUIDED CARRIAGE WITH POSITIONING ARM*, for which patent has been approved, serial no. 08/747020.
