WHEREAS, Charles E. Bradley and Samuel H. 

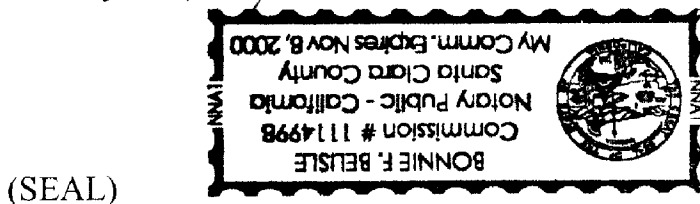
