AMENDED ASSIGNMENT

WHEREAS, Christopher Lee Pike, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled SEMICONDUCTOR FABRICATION EXTENDED PARTICLE COLLECTION CUP, for a full description of which reference is here made to an application for Letters Patent of the United States filed on February 26, 1999 and assigned Application Serial No. 09/258,834;

The Assignor hereby covenants and agrees, for both the Assignor and the Assignor's legal representatives, that the Assignor will assist the Assignee in the prosecution of the patent application identified above; in the making and prosecution of any other patent applications that the Assignee may elect to make covering the invention identified above; in


