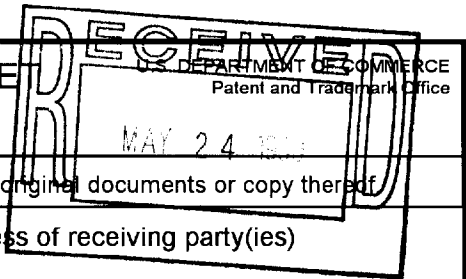

"FIRST. The name of the Corporation is:


