## A S S I G N M E N T

WHEREAS, I, DON ODELL, having an address at: 107 Catamount Drive, Milton, Vermont 05468, (hereinafter referred to as "Inventor"), have invented certain new and useful improvements in a SYSTEM FOR POSITION AND ORIENTATION DETERMINATION OF A POINT IN SPACE USING SCANNING LASER BEAMS, for which an application for United States Letters Patent is being filed concurrently, and
