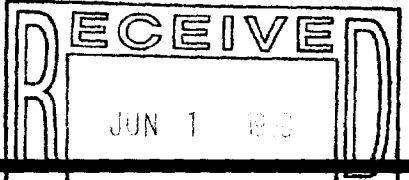





3.
