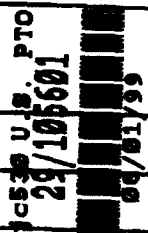

## ASSIGNMENT

**WHEREAS**, We, **Eric D. Green**, of Cleveland Heights, Ohio; **Shannon E. Mason**, of Avon Lake, Ohio; and **Eduardo Milrud**, of Chagrin Falls, Ohio; together with **James Edward Roth**, of Los Angeles, California; and **Melinda Jane Shafran**, of Reseda, California; have invented a certain new and original design for:
