THIS ASSIGNMENT, made by us, Eugene T. WHEREAS, we are the joint inventors of certain new and useful improvements in PIXEL STRUCTURE HAVING A BOLOMETER WITH SPACED APART ABSORBER AND TRANSDUCER LAYERS AND AN ASSOCIATED FABRICATION METHOD for which an application for United States Letters Patent has been executed by us concurrently herewith, and

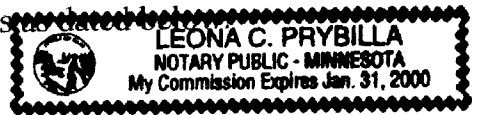
