

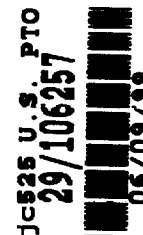

4. 
