ASSIGNMENT

WHEREAS, I, Jackie Yu, of the City of Los Angeles, the State of California, have invented a new and useful "Hair Tie" (design) , for which I have this 1<sup>st</sup> day of August, 1994, executed application papers for United States Letters Patent thereon; and

WHEREAS, Hairart Inc., a California corporation, having its principal place of business at 8112 W. 3rd Street, Los Angeles, CA. 90048, (hereafter, together with any successors, legal representatives or assigns thereof, called "Assignee") is desirous of acquiring the entire and exclusive right, title and interest in and to the said invention and in and to any Letters Patent which may be granted and issued therefor in the United States and throughout the world;

NOW, THEREFORE, in consideration of the sum of ONE DOLLAR (\$1.00) to me in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, I, Jackie Yu, has sold, assigned, transferred and set over, and do hereby sell, assign, transfer and set over to Assignee, Hairart Inc., the entire right, title and interest in and to said improvements, and said application and all divisions, substitutes and continuations thereof, and all United states Letters Patents which may be granted thereon and all reissues and extensions thereof, and all priority rights under the International Convention for the Protection of Industrial Property for every member country, and all applications for patents (including related rights such as utility-model registrations, inventor's certificates, and the like) heretofore or hereafter filed for said improvements in any foreign countries, and all patents (including all extensions, renewals and reissues thereof) granted for said improvements in any foreign countries; and I, Jackie Yu, hereby authorize and request the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid,

**AND I HEREBY** further covenant and agree that I will communicate to Assignee, Hairart Inc., any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.
